We hope everyone enjoyed their holidays!

In the 10 months that the current Board of Directors have been in place we have managed to accomplish the following:

1. Pay off the delinquent street light bill (2 ½ yrs. of nonpayment) and reestablish services
2. Pay off the delinquent attorney bill – stopping it from being sent to a collection agency
3. Pay off the delinquent software bill and cancelled those services as they were not being used
4. Obtain software that allows the convenience to make your payments online
5. 2yrs of taxes filed
6. Obtain liability insurance (which is required by law for HOA's)
7. Create avenues of communications for homeowners to reach the HOA Board
8. Create a website (required via SB1588)
9. Created the Architectural Committee in accordance to SB1588
10. Obtained a mowing contract for the common areas that includes the retention ponds
11. Removed the damaged playscape
12. Repair a damaged mailbox kiosk
13. Re-established the Holiday Decorating Contest (that included all residents within the HOA)
